2. The documents produced by the school Management including affidavit and on the recommendations of Distt. Education Officer (S.S.) Ludhiana and Director Education Department (S.S.) Punjab Mohali, the NOC upto Senior Secondary level has been granted on the following terms and conditions:-

1. In future on any complaint/ during inspection if this fact comes into light, that at the time of obtaining the NOC, the applicant has given the false information or you are not agree to abide by the terms and conditions of the Punjab Govt. from time to time and will not abide by the terms and conditions given in the affidavit, in that condition the NOC can be withdrawn.
2. Punjabi Subject will be compulsory upto 10th Standard in your school. CBSE, New Delhi will make necessary arrangements to conduct examination in these type of schools and it is stated that in case of failure the NOC will be cancelled.
3. School Management will abide by the terms and conditions of the notifications issued under R.T.E. Act 2009 and will abide the rules of R.T.E. Act of Punjab State.
4. After receiving the Affiliation of CBSE New Delhi, the Management of the school is bound to provide salary and other allowances to teaching staff and Non-Teaching staff at par with Govt. Employees in the form of account payee cheques.

Hon'ble High Court vide petition No. 17967 of 2022 order dated 17.08.2022, the school has not deposited some part of Reserve Fund. The school will be bound to pay the reserve fund according to decision of Hon'ble High Court in future failing which the NOC will be withdrawn.

You yourself and your management will also ensure that as and when any information is asked/ sought by concerned D.E.O. or any other senior official from Education Department, then school will cooperate and will provide the information desired by them. In case of not doing so, NOC will be cancelled.
6. The conditions of the safety of children, public health sanitation and other no objection certificates will be inspected from time to time by the officials of Punjab Govt.
7. You are directed to follow the guidelines issued by Punjab Govt. through/via letter No. 2/93/2009/3CJ/ 1360154 Dated 26- 11 -201 8.
